4. First-aid measures

Product AS SOLD and AT USE DILUTION

7. Handling and storage

Handling	: Use clean dispensing equipment. Use appropriate PPE. Remove all ignition sources. Avoid breathing of or contact with material. Use in well ventilated areas. Do not empty into drains. Do not eat, drink or smoke in contaminated areas. Before eating, drinking or smoking, remove contaminated clothing and wash hands. Do not store near strong oxidants.
Storage	: Keep container upright and cool and dry. Ensure good housekeeping in storage area. Store in original containers. Store in accordance with AS1940.

8. Exposure controls/personal protection

Occupational exposure limits	: No information available.
Engineering measures	: Use sensible work practices that reduce operator exposure to the product. Ensure that adequate ventilation is provided, and air is moving constantly in the area of use while drum is open. Keep containers closed when not in use.

Hands	: Use solvent resistant gloves (nitrile for longer term protection or PVC and neoprene for incidental splashes).
