SECTION 5: Firefighting measures

Extinguishing media

Advice for firefighters

Protective actions during firefighting Avoid breathing fire gases or vapours. Evacuate area. If a leak or spill has not ignited, use water spray to disperse vapours and protect men stopping the leak. Control run-off water by containing and keeping it out of sewers and watercourses.
